Temple Carrig School

Higher Years Admissions Policy 2019

1. Introduction

Temple Carrig School ("the School") was established to provide secondary education for children in the Greystones/Delgany area and also to make some provision for children attending primary schools under Church of Ireland patronage from outside the immediate catchment area. The Patron of the School is the Church of Ireland Archbishop of Dublin and Bishop of Glendalough and the Board of Management is accountable to the Patron for upholding the particular ethos of the School.

In September 2019, enrolment for First Year students will operate in accordance with the general Admissions Policy for the School ¹ Applications for places in higher year groups, however, shall operate in accordance with the terms of this Policy and its Appendix A Guide to the Temple Carrig School Higher Years Admissions Procedures.

2. Enrolment of Sixth Year Students

Places will not be offered in Sixth Year 2019.

3. Enrolment Policy – Second, Third, Transition and Fifth Year 2019

Places will only arise in these higher year groups in September 2019 if the school receives written notice of the withdrawal of an existing student. The Board has determined that the maximum number of students in each of the higher year groups in September 2019 shall be 144 students in Second Year and 132 students in all other year groups. The Board is not under any obligation or commitment to fill each year group to the maximum number and all decisions on awarding places under this Policy are made at the discretion of the Board of Management.

All applications for places at Temple Carrig School must be submitted on the approved application form. The application form may be downloaded from the School website or requested from the School Office. Applicants for places in higher year groups in September 2019 should also include copies of the most recent school reports. These reports will be used to gauge whether the applicant would integrate well into the School and their capacity to contribute to the life of the School, but will NOT be used to select candidates on the basis of academic merit or to eliminate candidates with special educational needs.

The allocation of places in higher years in Temple Carrig School will be made by way of self-contained rounds of offers. Each round of offers will determine the allocation of places in higher years by reference to:

- the number of places available in each specific higher year group
- the marking of applicants by reference to the criteria stated below
- the exercise of the Board's discretion to allocate places in the School

At the end of each round of offers, applicants shall be advised if they have received a place in the School. Any applicant who has not received a place will be offered an opportunity to be included in the next round of offers if they so elect.

The application period for each round of offers is as follows:

Round One – open from 11^{th} March 2019 until 5pm on 24^{th} May 2019 inclusive Round Two – open from 25^{th} May 2019 until 5pm on 28^{th} June 2019 inclusive Round Three – open from 29^{th} June 2019 until 5pm on 6^{th} August 2019 inclusive

Any applications received after the closing date for each round shall be deemed to be late and will not be considered for that round. The Board of Management insist that it is the responsibility of the applicant to ensure that their application is received on time for inclusion within the relevant round.

On 11th March 2019 all previous applications (including applications for places in First Year 2018) shall be deemed to have lapsed. If a family who made a previous application wishes their child to be considered for a place in higher year groups in September 2019 a new Higher Years Application must be made to the school on the official application form.

When considering the admission of any student the Board will take account of its obligations under health and safety legislation.

4. Allocation of Places in Higher Years

In respect of applications for places in higher year groups in September 2018 several criteria shall apply. After the closing date for each round, a Higher Years Admissions Committee will meet to consider all applications. The applications will be marked according to these criteria as follows:

1. Primary Residence

10 points shall be awarded to any child living inside the Greystones/Delgany Catchment Area²

2. Sibling connection to the school

10 points shall be awarded to any child who has a sibling who is attending, or has accepted a place in, the School

3. Capacity to Integrate into the School

0-20 points shall be awarded at the discretion of the Higher Years Admissions Committee based on their view of the capacity of the child to integrate into the School by reference to ethos, existing school attendance, discipline record and teachers' feedback about involvement and effort.

4. Potential to Contribute to the Life of the School

0-20 points shall be awarded at the discretion of the Higher Years Admissions Committee in respect of any special qualities or abilities that might add to the life of the School.

References/performance at interview shall NOT in themselves count for points. However, references may be sought from previous schools to determine or verify a student's entitlement to points under criteria 4 and 5 above and by applying for a place you consent to such references being sought.

The School will endeavor to review applications and offer places in each round by the following dates:

- Round One by 31st May 2019
- Round Two by 3rd July 2019
- Round Three by 8th August 2019

Following the conclusion of Round Three and the allocation of places within that round, a list shall be compiled of remaining applicants with the score that they secured in that round and the Board of Management will, at its discretion, allocate any places which become available between 9th August 2019 and 1st October 2019 by reference to the points received by each applicant under the scoring mechanism outlined above.

5. Acceptance of Places in Higher Years

Acceptance of an offer of a place in the School will be conditional on the School receiving, within the specified time period, a signed Acceptance of Offer form as well as any other documentary evidence that may be required. Failure to provide these details or the provision of details which are false or misleading will lead to the loss of a place in the School.

Acceptance of a place is taken as acceptance of all School policies³. Upon the offer of a place in the School, students and parents/guardians will be required to sign a copy of the School Code of Conduct indicating acceptance of current School rules regarding discipline and other matters. Refusal to sign the Code of Conduct or to accept School disciplinary procedures will lead to the loss of a place in the School.

Applicants should be aware that all places in some subject options may already have been filled by the time they enter the School and they may be restricted to the remaining available subjects.

6. Appeals

Appeals against the school's failure to enrol a student should be made in writing to the Board of Management who may decide that an oral hearing is necessary.

Section 29 Appeals

Section 29 of the Education Act, 1998, gives parents (and students who have reached the age of 18) the right to appeal decisions made by a school's Board of Management relating to expulsions, suspensions or refusals to enrol a student. If applicants are in any way dissatisfied with the School's handling of their application, they are entitled (within a period of 42 days) to address an appeal to the Secretary General of the Department of Education & Skills via the Section 29 Appeals Administration Unit, Department of Education & Skills, Friar's Mill Road, Mullingar, Co Westmeath. 7. Student Participation

The School is a voluntary co-educational day school, offering a broad Christian education through a wide curriculum of subjects approved by the Department of Education, together with sports and extra-curricular activities.

Religious Education and Assemblies are an integral part of the ethos and educational structure of the school. It is expected that students attending Temple Carrig School will participate in all areas of the school curriculum and pupils are encouraged to participate as fully as possible in the extra-curricular life of the school.

Students attending the School complete six years of schooling before sitting the Leaving Certificate. Requests to repeat or omit a year will only be considered in exceptional circumstances. Transition Year is compulsory for all students. All students in Temple Carrig School will be expected to own and use an iPad as part of their studies.

As specified under the Education Welfare Act 2000 all students registered at the School are obliged to attend school on a regular basis and parents/guardians also have obligations in this respect.

The Board of Management of Temple Carrig School is committed to excellence in education and the welfare of all students in its care. Once enrolled a student is subject to the discipline of the school and is entitled to remain as a pupil for as long as the discipline and rules of the school are obeyed. These rules apply in school, on school activities and where life in school is affected. ⁴

A Guide to the Applications Process in Temple Carrig School

Applying for a place in Higher Years in September 2019

Temple Carrig School experiences a substantial demand, and this makes it difficult to secure a place in the School. Conscious of this, as well as of the disappointment this can cause for families who are unsuccessful, the Board of Management are extremely careful to ensure that places are allocated as fairly as possible and adhere rigidly to the *Higher Years Admissions Policy 2019* (which can be requested from the School office or found on the School website www.templecarrigschool.ie).

This guide has been produced to help applicants understand how the process works, and to maximise their chances of securing a place.

Requesting an Application Form

The process begins when a family requests an application form from the School. This request can be made directly to the School office or downloaded from the School website. The school does NOT retain a record of how many application forms have been sent out to each family, however. Applications will only be considered once they have been returned on the official form. Requesting an application form does not constitute an application for a place in the School.

Cost of application

There is NO charge for making an application for a place in the School.

Closing Dates for Applications

The closing dates for applications for a place in higher year groups in September 2019 is determined by the round within which an application is made as follows:

Round One – until 5pm on 24th May 2019 inclusive Round Two – until 5pm on 28th June 2019 inclusive Round One – until 5pm on 6th August 2019 inclusive

Marking of Applications

Places only arise in Higher Years if the School receives written notice of the withdrawal of an existing student. In September 2019, the School will only be offering First to Fifth Year – places will not be offered in Sixth Year.

After each closing date, a Higher Years Admissions Committee will meet to consider all applications for higher year groups. The applications are marked according to the various criteria. These are outlined in the Higher Years Admissions Policy and it is strongly recommended that applicants familiarise themselves with them.

Once the Higher Year Admissions Committee has marked the applications, places will be offered to those with the highest points, according to how many withdrawals there have been from the year group.

TIP!

Clearly, it is important to score well in all the various categories. If you fail to submit up-to-date reports, your application will lose possible points. Likewise, if your child has the potential to make a special contribution to the

life of the School and you fail to tell us, they will miss out on possible points. Please let us know about any special interests, achievements or extra-curricular activities that your child undertakes – this information is not always obvious form school reports. Make sure you send in all the supporting documentation so that we can give your child the maximum points they deserve!

Acknowledgement of your application

All completed application forms received by the school are logged and dated, together with the accompanying supplementary information. You will receive a letter/email to confirm that this has happened.

We insist that it is the family's responsibility to retain proof of an application having been received because every year we encounter people who are "sure they applied ages ago". It is up to the applicant family to contact the school if they feel there may be a problem. If you don't hear from us within 14 days of making an application, please contact the school office immediately to confirm your application has been received.

Applying in Subsequent Years

If you are unsuccessful in getting a place for September 2019, you will need to re-apply for the following year if you are still interested.

Section 29 Appeals

Section 29 of the Education Act, 1998, gives parents (and students who have reached the age of 18) the right to appeal decisions made by a school's Board of Management relating to expulsions, suspensions or refusals to enrol a student. Frequently Asked Questions

FAQ: Our circumstances have changed. Our child has new school reports, or we now wish to be considered as a local application (and have the required documentary evidence). What should we do?

Ans: Once it's before the Closing Date for that Round of the Applications process, simply contact the School with the new information and this can easily be added to your child's file.

FAQ: Can I contact the school beforehand to find out where we stand on the Waiting List?

Ans: Prior to 8th August 2019 there <u>isn't</u> a Waiting List. Applications are simply stored carefully for assessment within each round until the last round is concluded after which point they are all marked together and form a Waiting List until 1st October 2019.

FAQ: Is it possible that my child will NEVER get a place in Temple Carrig School?

Ans: Unfortunately, yes. The School faces an extraordinary demand, and it's becoming harder and harder to get a place. We sincerely wish that this wasn't the case, and that we could take every applicant, but capacity restrictions and health and safety considerations mean that we have to set a limit on places in every year. You may indeed fail to secure a place for your child, but it's not something we're happy about.

FAQ: What can I do to improve my chances of securing a place in the school for my child?

Ans: Aside from making sure you apply on time and getting us the necessary information, there is NOTHING further you can do. The process is absolutely clear-cut and meeting the Principal, offering financial support or other assistance to the school, contacting politicians or clergy, etc make no difference to your child's application. (On the other hand, you can take comfort that your child cannot be queue-jumped by anyone else using such tactics either.)

FAQ: My child's existing school are already looking for an instalment of fees for next year. What should we do? Should we pay them or not?

Ans: It would be extremely unwise to jeopardise an existing school place until a place in Temple Carrig School is confirmed so unfortunately you may have to pay deposits, etc. It might be worth contacting us in advance, however, to see if we could liaise with your current school and get a commitment that it will be refunded if we eventually achieve a place for your child. This isn't always possible, but it's an avenue worth exploring.
